The "letter" was a very imaginative piece of material with references to the Occult or similar type of activity. Reference is made to STAR OF SEVEN and the NAME: BOHIPPUS DRACONIS is used rather than his own. The letter or whatever is addressed to ELDERBEAST. Appears to be codes and nick names being used.

The compl. explained that he and the other four males have been meeting very regularly near the River around Mennon, Sask. for some type of activity that she knows nothing about. He refuses to allow her to read his notes or poems. She has read a few when he has not been around and they are much more graphic than the attached copy. Apparently this "group" have been preparing for a "feast" of some type for the past few years. The compl. was worried that her husband had got mixed up with a Cult and was getting stranger by the week. She had left him a note this date that she needed some time alone and was going to her folks place in Hepburn, Sask. _____ The "group" never talk about what goes on at this camp outs or what takes them _____ hours to do.

With some of the other incidents happening in and around Martensville, this information was passed on to the R.C.M. Police for what ever action they deem required.

██████████ CALLED THIS DATE AT 09:30 HRS AND ADVISED THAT HIS SON ██████████ HAD DISCLOSED TO HIM WHAT WAS HAPPENING AT THE BLUE BUILDING - THE DEVIL CHURCH.

HE TOLD HIS MOTHER THAT HE HAS WITNESSED ONE ADULT AND TWO KIDS ABOUT HIS OWN AGE MURDERED AND THEN DISMEMBERED, ██████████ WERE FORCED TO ASSIST BY REMOVING BODY PARTS AND THE EYES AND THEN WITH THE CLEAN UP. THERE WERE OTHER VICTIMS WHO HAD INDICATED THAT THE WORST THINGS HAPPENED AT THE CHURCH AND THIS COULD EXPLAIN THEIR RELUCTANCE TO TALK ABOUT THEM. ██████████ INDICATED THAT JAMES ELSTAD AND ED REVESZ WERE PRESENT AT THESE TIMES AND POSSIBLE THAT FORD WAS ALSO AROUND.

██████████ ALSO TOLD THEM ABOUT BEING WITH TRAVIS STERLING AND ANOTHER GUY IN THE SECOND BLACK SPORTS CAR, WHEN THEY DROVE UP TO AN UNKNOWN MALE AND SHOT HIM - THEY THEN DUMPED THE BODY IN A HOLE AT AN UNKNOWN LOCATION.

CONSIDERING THE CREDIBILITY OF ██████████ REGARDING OTHER INCIDENTS AND THE CORROBERATION FROM OTHER WITNESSES I BELIEVE THAT THESE EVENTS DID TAKE PLACE.

THE TIME FRAME IS EARLY 1990-91 - IT IS UNDERSTOOD THAT A SKELETON REMAINS WAS LOCATED IN THE AREA IN 1991 AND WAS PICKED UP BY THE R.C.M.P. AND WAS TAKEN TO THE UNIVERSITY HOSPITAL FOR EXAMINATION (UNCONFIRMED).

THE INDICATIONS ARE THAT THIS IS GETTING MUCH MORE COMPLICATED AND INVOLVED THAN OUR DEPARTMENT CAN INVESTIGATE. A MEETING IS SET UP FOR TODAY WITH MOOR, BRYDEN, MYSELF AND THE PROSECUTOR FOR DIRECTION AND POSSIBLE RE-ARREST OF ALL SUBJECT FOR REMAND.

CST. BRYDEN, #211 CALLED AND ADVISED THAT THE [REDACTED] BOY WAS DISCLOSING OTHER INFORMATION TO HIS PARENTS ABOUT INCIDENTS THAT HAD OCCURRED TO HIM AND OTHERS WHILE AT THE "DEVIL CHURCH AND THE STERLING'S HOME". AN INTERVIEW IN THE "SOFT ROOM" HAS BEEN SET UP WITH HIM FOR SATURDAY THE 2ND OF MAY, 92 IN SASKATOON. FURTHER DISCLOSURES FROM HIM AND THE [REDACTED] BOY [REDACTED] MAY I.D. OTHER OFFENCES AND OFFENDERS INVOLVED IN THIS GROUP (STERLING'S, ELSTAD, REVEZS AND FORD).

CST. BRYDEN ALSO ADVISED THAT SHE WAS MAKING COPIES OF ALL VIDEOTAPED INTERVIEWS FROM THE PROSECUTOR SO THAT DISCLOSURE TO DEFENCE COULD BE MADE PRIOR TO ANY TRIAL.

ELSTAD IS MAKING HIS FIRST APPEARANCE (ELECTION - PLEA) ON MONDAY 4TH MAY 92 IN SASKATOON, SASK.

CPL. MOOR IS BACK TO WORK ON 5TH MAY, 92 AND I WILL SPEAK TO HIM AT THAT TIME REGARDING THE [REDACTED] INTERVIEW. I SHOULD TAKE PLACE PRIOR TO THE SUSPECTS REVEZS AND FORD BEING APPROACHED.

I HAVE IN MY POSSESSION A VIDEO TAPE OF MY SNEERING IN AT THE POLICE STATION ON 92-MAR-02 AT WHICH TIME ALL THE CURRENT MEMBERS OF THIS DEPARTMENT WERE PRESENT, INCLUDED WERE ELSTAD AND HIS WIFE AND FORD ALONG WITH SEVERAL TOWN OFFICIALS.

I AM PREPARED TO MAKE THIS AVAILABLE FOR WITNESSES TO VIEW TO I.D. SUSPECTS.

IT IS ANTICIPATED THAT THERE WILL BE OVER 100 CRIMINAL CHARGES AGAINST THESE PERSONS PRIOR TO THE END OF OUR INVESTIGATION AND WE DO NOT EXPECT TO HAVE EVERY MEMBER IDENTIFIED OR CHARGED WITH OFFENCES BECAUSE OF THE VERY SECRET NATURE OF THE CULT.

THIS DATE [REDACTED] ATTENDED THIS OFFICE WITH HER HUSBAND AND WANTED TO GIVE ME INFORMATION ON RITUAL ABUSE. SHE ADVISED THAT SHE HAD BEEN A VICTIM OF ABUSE AT THE HANDS OF HER FATHER WHO WAS AN ACTIVE SATANIST AND AN ELDER WITH THE SATANIC CHURCH OPERATING OUT OF SASKATOON, SASK. SHE HAD REPORTED INCIDENTS EARLIER TO SGT. DRUMMOND OF THE SASKATOON POLICE SERVICE WITHOUT ANY ACTION BEING TAKEN, IN HER VIEW. SHE ALSO INDICATED THAT HER FATHER ATTENDED A REGULAR CHURCH IN SASKATOON AS A COVER FOR HIS ACTIONS - [REDACTED]

[REDACTED] CLAIMS THAT SHE WAS REGULARLY ABUSED SINCE HER BIRTH UNTIL MOVING TO THE WALDHEIM AREA IN ABOUT 1987. SHE ADVISED THAT HER FATHER TOOK HER AND OTHER FAMILY MEMBERS TO RURAL LOCATIONS IN THE SUMMER WHERE THEY WERE SEXUALLY ABUSED - ORAL SEX, BEASTIALITY, SODOMY AND CONFINED BY RESTRAINTS (I.E. ROPES OR BELTS). SHE WAS ABUSED BY BOTH MALE AND FEMALE OFFENDERS AND WAS GIVEN DRUGS (NEEDLE) BY HER FATHER - THESE MADE HER HAVE HORRIFIC VISIONS AND GET DIZZY.

SHE INDICATES THAT SHE WAS TAKEN TO A COUPLE RESIDENCES INSIDE THE CITY LIMITS WHERE RITUAL ABUSE TOOK PLACE AND WHERE SHE AND SEVERAL OTHER YOUNG GIRLS WERE FORCED TO ENGAGE IN PROSTITUTION AT THE AGE OF 12-13 YEARS. THIS HOUSE WAS OPERATED BY A WOMAN - AGED 50 YRS WHO WOULD SENT THE CHILDREN TO A LOCATION WHERE THEY WOULD BE PICKED UP AND ENGAGE IN THE SEXUAL ACT REQUESTED. THEY WOULD GET PAID AND RETURN THE MONEY TO HER FATHER.

[REDACTED] ALSO INDICATED THAT [REDACTED] FROM THE ABOVE NOTED CHURCH HAD SEXUALLY ASSAULTED HER IN THE CHURCH BUILDING AND ONCE AT A RURAL LOCATION DURING A RITUAL. THEY HAD CAUGHT "SNAKES" AT PIKE LAKE AND THEN SHE WAS FORCED TO ENGAGE IN SEXUAL INTERCOURSE WITH [REDACTED] WHILE HOLDING ONTO THE SNAKES.

[REDACTED] ADVISED THAT AT THE AGE OF 13 YEARS HER FATHER HAD COMMITTED A HUMAN SACRIFICE OF A BABY NEAR SASKATOON, AND THAT SHE WAS FORCED TO HOLD THE KNIFE WITH HIM. THE REMAINS WERE BURNED AND THEN TAKEN TO REGINA BEACH, NEAR THE COTTAGE OF HER GRANDFATHER AND BURIED.

[REDACTED] STATED THAT HER BROTHER, [REDACTED] AND SISTER [REDACTED] WERE ALSO VICTIMS AND THAT ANOTHER SISTER, [REDACTED] WAS AN OFFENDER ALONG WITH HER FATHER, AND FATHER WERE INVOLVED IN A RELATIONSHIP AND SHE HAS MOVED TO ENGLAND.

██████████ ADVISED THAT HER FATHER WAS INVOLVED IN THE SATANIC CULT ALL HIS LIFE AND USED TO KEEP SOME OF HIS "ITEMS" IN THE ATTIC AT ██████████, SASKATOON AND IN A LOCKED ROOM IN THE GARAGE AT THE SAME LOCATION. HE HAD ROBES (WHITE WITH MARKINGS, KNIFE ETC.)

██████████ INDICATED THAT SHE WAS RAPED BY HER FATHER EVEN AFTER SHE GOT MARRIED AND WAS LIVING IN MARTENSVILLE, SASK. AND THAT HE HAD ATTENDED HER RESIDENCE ONE TIME BEFORE THE BIRTH OF HER BABY AND BAPTIZED THE UNBORN CHILD TO SATAN. HER FATHER IS REPORTED TO HAVE ASSAULTED (SEXUALLY) BOTH OF HER CHILDREN IN SASKATOON AND MARTENSVILLE, SASK.

STATEMENTS WERE APPARENTLY SUBMITTED ON THE PREVIOUS INVESTIGATION FROM ██████████ HER SISTER AND DAUGHTER (ALL LISTED BELOW). SHE INDICATED THAT AT THE RITUALS (RURAL) THEY WOULD HAVE LARGE FIRES AND WOULD CUT UP ANIMALS AND BURN THEM AND THAT SHE WAS TIED UP ON ALL FOURS AND THEN SEXUALLY ASSAULTED AND FORCED TO HAVE SEX WITH A DOG WHILE TIED TO A TREE STUMP.

BLOOD AND URINE WERE OFTEN MIXED AND Poured ON PEOPLE OR DRUNK. SHE ALSO ADVISED THAT SHE WAS BURIED IN THE DIRT AND LEFT UNTIL DAWN ONE TIME WHICH WAS REPORTEDELY TO REPRESENT HER NEW BIRTH INTO SATANIC CHURCH. I ASKED HER IF SHE HAD A DIARY OR RECORD AND SHE STATED THAT SHE DID, SHE WAS ALSO WILLING TO TALK TO THE MEMBERS FROM THE TASK FORCE AND GIVE THEM ANY INFORMATION SHE COULD.

OF INTEREST TO USE WAS THAT DURING MY CONVERSATION WITH HER SHE INDICATED THAT ONE CHIEF OF POLICE AND TWO OTHER OFFICERS WERE ALSO INVOLVED IN THE ABUSE SHE COULD NOT RECALL THEM BUT THOUGHT THAT ONE WAS DARRYL FORD.

██████████ DOES SUFFER FROM A MULTIPLE PERSONALITY DISORDER AND SHE READILY ADMITS THAT TIMES IS DISTORTED FOR HER AND DATES ARE VERY HARD TO RECOUNT. WE WOULD APPEAR TO BE DEALING WITH A PERIOD FROM MID-70's TO 1987. SHE ADVISED THAT HER FATHER MAY HAVE TOLD ██████████ OF HIS AFFAIR WITH HER SISTER AND THAT ██████████ RESIGNED JUST AFTER THE DEATH OF HER FATHER IN MARCH OF 92.

SOME OF THE RITUAL SITES WERE NEAR THE QUEEN ELIZABETH POWER STATION, BY THE DUMPS, NEAR THE BORDEN BRIDGE, PIKE LAKE DIST. & AROUND S'TOON.

During the refit of our Police Van (210) to our replacement vehicle a car a small gold coloured cardinal Watch with the initials "DGK 1987" was found in the back area of van. It was turned over to Cst. Chudyk who promptly advised me and made it subject of Found Property Report #92-041 - copy on file.

Information will be passed on to Saskatoon City Police and R.C.M.P. FOR checks on complaints or missing persons from 1987- to 1992 that may relate to this investigation.

11:43 hrs called from a lady, who did not give her name at this time detailing dreams and things that she was being told by her children. The kids talk about being placed in a deep hole and that it was cold, babies being placed in toilet bowls and having to pull them out. She recalled one of the children talking about a "bear", but it was not real just someone dressing up like a bear and a van. The children really do not recall events, times or details and believe they are blocking out something that "may" have happened. She is concerned because they are or were friends of Elstad and her children were with Elstad alone at times. The oldest is now 13 years old.

I supplied her with the name of the McNeil Clinic and advised her to record every thing and if she wanted to come into the office and see me or one of the assigned investigators next week, I would be happy to talk to her.

Martensville Police Association wants to have Cst. Chudyk take a polygraph with outside agency - Robinson Investigations of Saskatoon, Sask. to eliminate him as a suspect and get him reinstated a.s.a.p. I passed this suggestion on to Saskatoon City Police - Cpl. Moor and he indicated he would try to get hold of their polygraphist and get approval for release of information etc. as of 92-06-06 11:45 hrs no reply has been received.

I had another lady call and advise me that this activity appeared to be related to a combination of native spiritualism (bad medicine) and other stuff but that there was a definite native influence in what was being reported in the papers. She also advised that [redacted] a.k.a. [redacted] age 32 years old was involved in something in the Martensville district and sounded similar and that her mother [redacted] was familiar with same.

Cpl. Moor advised that he had discovered a complaint from a few years ago about a group that included 2 R.C.M.P., City Police and Police from a small town that was degrading children - trying to outdo each other and they want to see who would be the first to kill a child. He has not been able to follow up on this at this time because of the Show Cause hearing. I sounds strikingly similar to our current investigation.
