Noted extremely stained interior surfaces of 4th floor indoor smoking room. Exhaust ventilation for this room should be directly outside and not linked to common ventilation system. Noted hallway makeup air through the doors.
Unfortunately the smoking room is part of the licensed facility and must be minimally maintained. Wall and ceiling surface need to be cleaned.
