

According to a court affidavit, Mobina Jaffer's son, Azool Jaffer-Jeraj, billed for 32.4 hours on Sept. 29, 2003, at a rate of \$200 an hour, totalling \$6,480. That day ended a week (Sept. 22 - 29) in which he billed for an average of 20 hours a day.
